Dear Apostles Church Family,

I am pleased to report to the membership of Apostles Houston that our financial condition is stable and, thanks to the generous support of our membership we have been able to add several staff positions to serve our growing congregation. Our budget has been impacted by the inflation pressures over the last year, so we have increased our expenditures in most areas.

However, we have been able to decrease budgeted capital expenditures from last year. We have also budgeted a \$650,000 capital reserve to help pay down our mortgage on the church property on West 14th when that debt matures in approximately 2 ½ years. These funds came from the sale of our Bayland rectory last Fall. We are earning interest on these funds in excess of our rate on our mortgage, so it has a positive impact on our overall finances.

God has blessed our church with new members joining and faithfully giving their Tithes to support the mission of Apostles here in Houston and in the world.


